Discount:	

- Renewal of registration before it expires will receive a 20% discount of the base fee.
- Non-profit business are exempt from fees
- Plumbing contractors are not required to pay a plumbing registration fee or administration fee.

## Registration:

- a. The registration is for one year, which begins January 1<sup>st</sup> and ends December 31<sup>st</sup>, and must be renewed annually as long as the business is active.
- b. Registration fee(s) will not be pro-rated & are non-refundable.
- c. Plumbing Businesses/Contractor are not required to pay a plumbing registration fee or administrative fee, however they are required to register.

## **Exclusions/Exceptions:**

- Vendors must register under ordinance 0092
- Home Occupation Business must register under ordinance 0102, Section 9
- Utility company holding a franchise issued by the City and performing work addressed in the franchise shall not be required to register.
