1. Application for Sign Permit *completely* filled out.
2. Two sets (2) of site plans to be submitted showing the following:
 - o Address & Legal description of property
 - o Elevations
 - o Location Map showing nearest street intersection w/abutting arterial
 - o Nearby buildings & structures to the location and distance
 - o Nearby signs to the location of proposed sign.
 - o Property lines
 - o Driveways
 - o Size
 - o Height
 - o Setbacks
 - o Type of construction

Note: Building Official may require plans to be prepared by a registered professional engineer or architect.

3. Two (2) blueprints or ink drawing of plans and specification showing:
 - o Method of construction
 - o Attachment to the building or ground
 - o Size
 - o Type
 - o Height
 - o Construction Materials
 - o Exact mock-up or Sign proof
 - o Bear Underwriter's Laboratory Label (built to comply with Underwriters' requirements)
4. Digital Copies of Plans and Schematics.
5. Highway Department License if sign is located within Highway Control Zone.
6. Electrical Permit (electrical signs). *Separate permit application & Electrical Contractor registration is required.*

Electrical Signs: If this application is for an electrical sign, then plans must be drawn or designed by a Master electrician or an electrical engineer.
